# VITA – Volunteer Income Tax Assistance

### What is VITA?

Volunteer Income Tax Assistance (VITA) is a Free Tax Return Preparation Program for low to moderate income families and individuals. The utilization of free tax preparation sites allows low-income working families to keep significant amounts of their income in their own pockets that would otherwise be paid to a paid tax preparer.

## Tax Counseling for the Elderly

In addition to VITA, the Tax Counseling for the Elderly (TCE) Program offers free tax help for all taxpayers, particularly those who are 60 years of age and older, specializing in questions about pensions and retirement-related issues unique to seniors. The IRS certified volunteers who provide tax counseling are often retired individuals associated with non-profit organizations that receive grants from the IRS.

#### VITA Facts

- Volunteers assisting with the VITA Program come from all walks of life: retirees, college and high school students, IRS employees, and people who just want to help in their communities.
- Certified volunteers sponsored by various organizations receive training to help prepare tax returns in communities across the country.

### VITA Facts - continuation

 VITA sites are generally located in community and neighborhood centers, libraries, schools, and other convenient locations. Most locations offer free electronic filing.

 The VITA Program income eligibility is based on the Earned Income Tax Credit income limits.

- Form SS-8 (determination of worker status for purposes of federal employment taxes and income tax withholding)

#### What to Bring

- . For married filing joint, both spouses must be present
- All Forms W-2 and 1099
- · Information for other income
- Information for all deductions/credits
- · A copy of last year's tax return
- . Proof of account for direct deposit of refund
- Social Security cards or Individual Taxpayer Identification notices/cards for you, your spouse, and/or dependents

- Proof of identification for yourself and/or your spouse
- Total paid to day care provider and their tax ID number
- . Birth dates for you, spouse and or dependents on the return
- Proof of foreign status if applying for ITIN
- Forms 1095-A, B or C (Affordable Health Care Statements)
- For prior year or returns, copies of income transcripts from IRS (and state, if applicable)
