# **Hospital Rate Setting**

- Due to some COVID-19 related delays, not all HSN FY21 schedules will be immediately available
- The following schedules are currently available and will be distributed:
  - Schedule A: Inpatient Medical and Psychiatric
  - Schedule B: Payment on Account Factor
  - Schedule C: Outpatient Rates
  - Schedule D: Outpatient ERBD Rates
- Please note that there is no information yet for Special Hospitals or Inpatient Rehabilitation facilities
- For those schedules we are not able to update, the HSN will:
  - Send the schedules/rates out as soon as possible and allow 30 days for facilities to comment
  - Reprocess the claims once either the 30 day comment period has expired or we have heard back from all providers



#### **HSN Regulation Updates**

- HSN is in the process of proposing changes to the 101 CMR 613.00 and 614.00 regulations
- These updates along with a public comment period will be posted to the HSN website



#### **340B Pharmacy Changes**

- Recent changes in the pharmaceutical industry have created barriers for contracted pharmacies to obtain certain 340B drugs
- In order to ensure patient access to these drugs, the Health Safety Net will allow Health Safety Net providers and their contract pharmacies to utilize non-340B stock to fill prescriptions for their Health Safety Net patients for drugs that are 340B-eligible but that are no longer available for purchase by the contract pharmacy at 340B price
- Such non-340B stock must be billed to the Health Safety Net at Actual Acquisition Cost
- Dispensing fee will be added per 101 CMR 613



#### **340B Pharmacy Changes**

- The Health Safety Net will continue to require that 340B Providers submit only 340B claims to the Health Safety Net for 340B-eligible prescriptions provided to Health Safety Net patients
- Health Safety Net contract pharmacies must continue to utilize 340B drugs that are in stock or available for purchase at 340B price when filling prescriptions for Health Safety Net patients
- A 340B provider that operates both a 340B pharmacy and retail pharmacy must fill prescriptions for any Health Safety Net patient



# **CHC Reprocessing**

- In January 2021, the HSN will be reprocessing claims for the following CPT codes:
  - Price adjustments for J7296, J7297, J7298, and J1050
  - Removal of J7301
  - CHC Secondary Over and Underpayments
- HSN will notify providers in the near future



#### **Shingles Vaccine Update**

- The Health Safety Net will now allow CHCs to bill for Shingrix, the new zoster vaccine (CPT 90750)
- This vaccine will be reimbursed at \$112.38



#### **Interim Payment Reconciliation**

- Interim payment recovery began with the August 2020 pay cycle
- During interim payment recovery, a provider's monthly payment will be reduced by a calculated recovery amount to reflect the payments made during interim payment periods



#### Interim Payment Reconciliation: Acute Hospitals

- For each recovery month the interim payment recovery amount is determined by comparing a provider's monthly demand, based on claims submitted to MassHealth, POPS (for pharmacy claims), or DentaQuest (for dental claims), and the monthly interim payment balance
  - If monthly demand is less than 2 times the one-month interim payment amount, then the recovery will be equal to half of monthly demand), up to the amount of the remaining interim payment balance
  - If monthly demand is greater than or equal to 2 times the onemonth interim payment amount, then the recovery will be equal to monthly demand minus the one-month interim payment amount, up to the amount of the remaining interim payment balance.
- The HSN will continue with the recovery formula until the entire interim payment balance has been recovered



### **Interim Payment Reconciliation: CHCs**

- For each recovery month the interim payment recovery amount is determined by comparing a provider's monthly demand based on claims submitted to MassHealth, POPS (for pharmacy claims), or DentaQuest (for dental claims), and the monthly interim payment balance
  - If monthly demand is less than 2 times the one-month interim payment amount, then the recovery will be equal to half of monthly demand), up to the amount of the remaining interim payment balance
  - If monthly demand is greater than or equal to 2 times the onemonth interim payment amount, then the recovery will be equal to monthly demand minus the one-month interim payment amount, up to the amount of the remaining interim payment balance.
- The HSN will continue with the recovery formula until the entire interim payment balance has been recovered
